Meeting the diverse needs of people who inject drugs (PWID) can present many challenges—even more so in rural settings. There are barriers to ensuring equitable access to preventative measures such as PrEP/nPEP and HIV/HCV treatment regimens, and these barriers can be very different from those in major metropolitan areas. Combined with the stigmas of drug use and communicable disease, in addition to the COVID-19 pandemic, these issues can become even harder to address.
